Notice to Customers/Employers

The extra-duty employment deputies are at all times subject to the policies, rules, and regulations governing employees of the Walton County Sheriff's Office (WCSO). A customer has no authority over WCSO personnel and is restricted to providing only a general assignment of duties to be performed by extra-duty employment deputies. HOA rules, CAM rules, and rules established by private property owners NEVER supersede WCSO policy or procedures and employers of the extra-duty employment deputies should be so advised. Extra duty employment deputies remain under exclusive control of the WCSO and are accountable for strict adherence to WCSO rules and regulations. Any conflicting rules of employers of extra-duty employment deputies will be disregarded. The extra-duty employment deputies shall refuse to perform any duties deemed to be in conflict with guidelines established by the WCSO. As determined by the WCSO, extra-duty employment deputies may be recalled to on-duty status at any time for emergency or needed operations.
